1. **Certificate of Insurance** furnishing proof of coverage amounts as listed in the by-law.
2. Vehicles, using propane or other hydrocarbon fuel for the preparation, and/or heating of food products, must provide a current **Technical Standards & Safety Authority (TSSA)** inspection certificate from a licensed gas technician.
 - Refreshment vehicles built after 2006 need TSSA Field Approval or certification label.
3. Current or most recent **Food Safety Inspection Report** from Southwestern Public Health showing the operation is in compliance.

4. Proof of Fire Inspection by St. Thomas Fire Department. Fire Inspector to provide information below
