HEARING OF APPLICATIONS

B08/21 - Novi Construction Limited - 358 Wellington Street

Mr. Nick Ostojic, 358 Wellington Street provided an overview of the Consent application.

Mr. Ostojic advised that the plan is to demolish the existing house on the retained lands in August and that the new house on the severed portion would be constructed this year.

Ms. Laurie MacDonald, 362 Wellington Street inquired about future plans for the retained property.
