HIGHLIGHTS OF CITY COUNCIL MEETING: FEBRUARY 6, 2023

TALBOT STREET CONSTRUCTION PHASE 3

Council has voted to accept the tender submitted by Cassidy Construction London Ltd in the amount of \$6,571,674.85 (excluding HST) for the Talbot Street Construction Phase 3 (Mary Street to Ross Street).

The project is expected to start mid to late March following tender awarding and receipt of required documentation. Construction duration is expected to be 6 months with a substantial completion date of September 29th, 2023. The project has been split into two phases to minimize social-economic impacts.



COYNE STREET AND SIMCOE STREET CONSTRUCTION

Council has accepted the tender submission from Cassidy Construction London Ltd in the amount of \$3,469,777.43 (excluding HST). The scope of the project generally includes the replacement of watermain, replacement of sanitary sewer, new storm sewer, new sidewalk on Simcoe Street, curb and gutter, and new asphalt driving surface. While a new sidewalk on Coyne Street won't be added, the existing public walkway from Coyne to Elm Street will be renewed.

PARKSIDE DRIVE AND BELL AVENUE CONSTRUCTION

Council has accepted the tender submission from PV-EX Construction in the amount of \$3,999,691.81 (excluding HST). The scope of the project generally includes site dewatering, replacement of watermain, replacement of sanitary sewer, decommissioning of old sanitary pumping station, new storm sewer, new sidewalks, curb and gutter, and new asphalt driving surface.



DRINKING WATER QUALITY MANAGEMENT SYSTEM

Council received a report as information from the Manager of Development and Compliance regarding an operational plan and policy for the St. Thomas water distribution system. Council approved the Drinking Water Quality Management Operational Plan and Policy which reaffirms their commitment to the obligations under the Safe Drinking Water Act, 2002.

COMMUNITY GRANTS

The Director of Finance and City Treasurer brought forward a report on community grant applications as information. Council moved to approve the recommended Community Grant requests which total \$5400.00.
