The system has high and low pressure areas with two Pressure Reducing Valves & chambers.

The re-chlorination facility houses -

Two chemical pumps - one duty one standby

Two chlorine analyzers - one inlet, one outlet

A flow meter that paces the chlorine addition

Scada System with Alarms.

The Southwold system supplies a percentage of the supply to the Dutton/Dunwich system through the Iona interconnect. Water is also supplied to a subdivision of the city of St. Thomas through a meter on Fingal Line.

- Replace 14" flow meter with a new ABB flow meter and remote transmitter in 14" trunk main at Shedden booster station located at 36513 Talbot Line.
- Continuous progress on Municipal backflow prevention program.
