# **Activity Report and Recruitment Projects - Cheryl Fish**

The members were provided with the Health Recruiter's Activity Report for the Month of October.

Ms. Fish advised that she had attended recruitment events at McMaster University and in Ottawa and that she had a number of contacts to follow up with.

Ms. Fish discussed the Discovery Week placement and the larger role the community had compared to previous years. She further advised that the organizers would be looking to improve its pairing of participants and municipalities.
