**Approval of Minutes – January 24, 2017**

#### **Activity Report and Recruitment Projects - Cheryl Fish**

The members were provided with the Health Recruiter's Activity Report for the Months of February and March, 2017.

Ms. Fish provided the members with an update on efforts to develop and/or participate in an orientation program for new physicians. A survey had been sent to Dr. Bezuidenhout to gather feedback on his recent orientation meetings.
