Update Report February 2018

Activities:

He is interested in doing both opportunities which I'm sure he will find very helpful. Dr. Osagie has agreed to do the same thing Dr. Scott has done and will send a letter to any of her patients that are from the west notifying them of the new doctor in Dutton and give her blessing if they wish to transfer to Dr Kamar.
- 2) Kim Vo provided me with the contact information for two new medical students from Elgin County. Maggie McNeill who is attending McMaster University and Riley Jones attending University of Ottawa. I've sent them scholarship information and invitations to attend our social event on March 11th.
